**SUBJECT:** Compensation Board Budget Estimates for FY15

As you know, at this point in the budget development process we would normally have provided you with budget estimates and have notified you of the date for the Compensation Board budget hearing within two weeks after adjournment of the regular session of the General Assembly, as required by §15.2-1636.8, Code of Virginia. However, as the General Assembly did not approve a budget during their regular session and have not yet reached a decision on the budget during the current special session, we have been unable to provide an estimate yet of Constitutional Officer budgets for FY15.

The General Assembly began meeting in a Special Session on March 24. We anticipate being able to provide you with budget estimates within 5-7 workdays after adjournment of this Special Session. We will also let you know of the date/time/place of the budget hearing when we provide you with the estimates. Additionally, the Compensation Board cannot approve Constitutional Officer budgets until after the "Veto" Session for the Special Session is held. The "Veto" Session will occur on the sixth Wednesday after the Special Session adjournment, and the Compensation Board will provide such approved budgets as soon as possible after this date.
