LISTED BELOW	SHERIFF	<p>Officer previously requested to transfer the salaries of 15 C7 permanent personnel positions to Office and Vehicle Expense which was deferred at the last Board meeting pending further review.</p> <p>The Officer stated that his office does need the 15 C7 positions in their Permanent Personnel budget. Due to staffing shortages, they consistently average 27 vacancies per month. The Officer is working diligently with the City to come up with a recruitment plan to attract candidates.</p> <p>The Officer is asking to transfer the funds of these 15 positions to Office and Vehicle Expense to help offset some of the expenses incurred that pertain to the maintenance of the fleet of vehicles in the Sheriff's Office. In FY07 approximately \$522,000 was spent by the City on expenses that would be considered reimbursable in the Compensation Board's Office and Vehicle Expense budget line.</p>	-0-	<p>The Compensation Board did not approve this request. As a part of budget reductions in FY04, the Virginia Sheriffs' Association agreed to the elimination of the use of accumulated vacancy savings as an alternative to cutting salaries or positions, and Compensation Board policy since then has prohibited the use of vacancy savings except in limited circumstances. The exception to policy allowing for the transfer of annual vacancy savings is intended to allow for the purchase of medical and food service contracts in jails in lieu of staffing for these purposes, and to provide flexibility in Sheriffs' offices for hiring part-time or temporary staff where necessary for operations. This exception is not intended as a means to bypass the policy of withholding vacancy savings accrued in the course of normal office attrition.</p>
