**SUBJECT:** Compensation Board Budget Estimates for FY23

As you know, we would normally be providing you with budget estimates and notifying you of the date for the Compensation Board budget hearing today, two weeks after adjournment of the General Assembly, as required by §15.2-1636.8, Code of Virginia. However, as the General Assembly did not approve a budget during their regular session, we are unable to provide an estimate of Constitutional Officer budgets for FY23 at this time.

The General Assembly will begin meeting in a Special Session on April 4. We anticipate providing you with budget estimates within 5-7 workdays after adjournment of this Special Session. We will also let you know of the date and time of the budget hearing to be held in Richmond when we provide you with the estimates.

Additionally, the Compensation Board cannot approve Constitutional Officer budgets until after the Reconvened "Veto" Session for the Special Session is held. The "Veto" Session is typically held on the sixth Wednesday after the Special Session adjournment, and the Compensation Board will provide such approved budgets as soon as possible after this date.
